Certification of Results
American Postal Workers Union, Local 732

Pursuant to a letter of agreement with the American Postal Workers Union (“APWU”), the American Arbitration Association (“Administrator”) agreed to conduct an Election of Officers for American Postal Workers Union Local 732.

APWU provided the Administrator with a list of eligible voters. Two Thousand Six Hundred Thirty-Six (2,636) ballots were mailed to eligible voters on Friday, January 23, 2026.

To be counted, ballots had to be received by the Administrator no later than 9:00 AM on Thursday, February 26, 2026. The Administrator received a total of Eight Hundred Ninety-Eight (898) ballots by the deadline scheduled. Two Hundred Fifty-Three (253) envelopes were set aside and not counted.

Materials – Voter did not use official voting materials.

Dupe – Two ballots received from the same voter. One ballot was counted and the other was voided.

Multiple – Two ballots received from different voters in the same priority mail envelope. Ballot from mailer was counted and ballot from non-mailer was voided.

The tabulation of results took place at 10:00 AM ET on Thursday, February 26, 2026, at the Administrator's office located at 120 Broadway, Concourse Level, New York, NY 10271 in the presence of virtual observers via Zoom.


The secrecy of the votes was maintained at all times. The results are certified as follows:
