- HR 756 Postal Service Reform Act of 2017
- S 2629 Postal Service Reform Act of 2018
- HR 676 Expand & Improve Medicare for All -guarantee free health care to all
- HR 1205 Social Security Fairness Act of 2017-Repeals the GPO and WEP)
- S 915 Social Security Fairness Act of 2018-Repeals the GPO and WEP)
- HR 1251 CPI-E Act of 2017- COLAs based CPI-E (Consumer Price Index for the Elderly).
- S 427 Social Security Expansion Act Scraps the payroll tax cap on income above \$250,000.

APWU Constitution and By-Laws

ARTICLE 16

Fiscal Year, Revenues, and Charters

SEC. 2. REVENUES.

(i) Ten (10) or more Retirees Department members residing within a local or area local geographical jurisdiction may form a Local Retiree Chapter. Chartered Local Retiree Chapters shall receive forty percent (40%) of the annual retiree per capita tax per retiree member of that local chapter.

One dollar (\$1.00) per month shall be passed on to existing local and state retiree chapters where they now exist or may be organized in the future.

Where there are no retiree chapters in existence, the one dollar (\$1.00) shall be retained by the Retirees Department in an organizing fund, to be disbursed solely for organizing activities by the Retirees Department.

 - · Limit meeting time to no more than two (2) hours
 - Start as scheduled & End as scheduled
- Break Bread Together
 - · Hold Meetings at Restaurant
 - Serve Box lunches
 - Serve Continental Breakfast
- APWU Local Involvement
 - Invite the Local President or designee to come to the meeting and ask for involvement of retirees, etc.
 - Volunteer in the local as mentors, work on committees, etc.
